## **Headline summary**

- We've now renamed the Next Generation Text Relay / NGTR / NGT service to Relay UK and this is reflected where appropriate in this Annual Report
- Underlying Standard call volumes have declined slightly compared to last year
- Emergency Relay and in particular emergency SMS calls, whilst still at a low volume, have increased by c.20% year on year
- Average relay call durations are slightly higher than a year ago
- The percentage of calls made using the relay app versus traditional methods such as Textphones, has continued to increase and in September 2019 was over 60% of the total
- Reported monthly Key Performance Indicators are presented in Annex 1

## 15.3 & 15.5) criteria
